His photos have been featured in several dozen issues as well as many covers over the last few years.





## Garcinia Cambogia

As Seen on the Dr. Oz show

### What Is Garcinia Cambogia Extract?

Garcinia cambogia is a small, pumpkin-shaped fruit, sometimes called tamarind. Though native to Indonesia, it is also grown in India, Southeast Asia, and West and Central Africa. It has long been used in traditional South Asian dishes, including curries and chutneys. Many also use the fruit for curing fish and preservation.

Adding this ingredient to meals is considered to be effective in making meals more “filling.” In some villages in Malaysia, garcinia is used to make a soup that is eaten before meals for weight loss because of garcinia’s appetite-blocking abilities.

This plant offers one of the least expensive herbal supplements on the market. The ingredient from the rind of the fruit could hasten your weight-loss efforts. The natural extract is called hydroxycitric acid (HCA), and researchers claim that HCA can double or triple one’s weight loss.

With proper weight-loss efforts (dieting and exercising), the average person taking HCA lost an average of four pounds a month.

Garcinia may also be great for emotional eaters. Those who participated in the study showed an increase in their serotonin levels; hence, it may also improve mood and sleeping patterns.

### How Does Garcinia Cambogia Work?

The HCA extract from garcinia cambogia supplement aids in weight loss by doing two things: It helps to block fat, and it suppresses your appetite.

HCA blocks fat by inhibiting a key enzyme that your body needs to make fat from carbohydrates: Citrate lyase. Usually carbohydrates or sugars that are not used immediately or stored in other forms are converted into fats. When HCA inhibits citrate lyase, the fat-making process is halted and the production of LDL (bad cholesterol) and triglycerides decrease.

HCA also suppresses appetite by increasing serotonin levels. Serotonin is a neurotransmitter in your brain that makes you feel good. It’s a target of many antidepressant medications. Having low levels of serotonin may make you feel depressed or anxious; it drives many people into emotional or reactive eating. By increasing serotonin levels, HCA improves mood and suppresses the drive to react to stressful situations with food. As you eat less, your body senses this and it releases stored fat in your fat cells.

Many studies have shown promise. One randomized placebo-controlled study followed 60 obese persons for 8 weeks. With a calorie-restricted diet (1200 kcal/day) and an HCA dose of 1320 mg/day, the experimental group lost an average of 14 pounds (compared to 6.1 pounds in the placebo group). The participants also noted reduced appetite.

### Is It Safe?

The plant and its fruit have been eaten safely for years. The HCA extract is also likely safe in normal amounts.

However, don’t take this supplement if you are pregnant or breastfeeding. If you are taking a diabetic medication (like insulin or glyburide), talk to a doctor before taking this to make sure this is right for you, otherwise this supplement may allow your blood sugar to fall even lower than normal.

Those taking a statin (a cholesterol-lowering drug) should use this supplement with caution because it can increase the risk of harmful side effects, like rhabdomyolysis or muscle degradation. Those with Alzheimer's disease or other forms of dementia shouldn't take HCA because of the risk of worsening dementia.

### How Much Should I Take?

You can buy garcinia cambogia extract in health food stores or online. When looking for a supplement, look for "garcinia cambogia" or "GCE" with at least 50% HCA (active ingredient potassium). Some experts believe that the newly available HCA potassium salts are more effective than the other HCA formulations.

Take 500-1000 mg before each meal, and make sure to take no more than 3000 mg total per day.

When looking for supplements, make sure you can see and review the list of ingredients.

Do not purchase if you can't see any ingredients. Furthermore, there should be no fillers or artificial ingredients.

With no other changes, you may lose 2-4 pounds within one month. However, it is highly recommended that the person taking HCA also find time for moderate exercise a few times a week and eat properly portioned meals.

Let the power of the HCA supplement work along with making healthier choices.





I felt after all my years of modeling this was a positive way to give back to those whom are in need. Being a survivor of cancer it hits home, I was lucky mine was caught early on, I had great medical

coverage and my family as a solid support team. Others are not so lucky.

**I would love to get you more involved with TFM. Besides fantastic modeling what other skills could you bring to TFM.**

I have management background, and am now moving towards mentoring, recruiting and coaching new and upcoming models. I would like to give some of our local beauties here in arkansas a chance to feel the experiences in modeling that I have had.

**I have actually been racking my brain to come up with a title for you...would you be willing to accept Director of TFM Social Networking?**

Would love too.. I had pretty much called myself "spokesmodel" as its a title of advertisement.

**I looked a little further into your background and after all these years of thinking that you just really liked Mustangs, I found out there is per-**

**sonal story behind your love of Ford cars, please share that with me.**

My dad had 2 daughters, he has worked off and on during my childhood for Ford Motor Company, and various other local dealerships and a mechanic.

Back in the 60's my dad in his early 20's had the opportunity to meet Carroll Shelby at his plant in Las Vegas, NV this was back in the day obviously when the shelby mustangs were built with busted knuckles, sweat and hard work.

In 2002 my Dad suffered a massive stroke, we almost lost him. Sometime during 2006 my dad after extensive therapy regained some speech. We were sitting on a sunday afternoon watching mustangs across america. See the one thing alot of people do not know is, there is so much more to owning a mustang then driving a car, mustang owners become a family, friends mutual interest brings us together.

There is Mustang week which is held every year. A full week of mustang shows, events, races you name it it all goes down during July of every year.

In April typically in california there is Faboulous Fords which is held in Southern Calif at Knott's Berry Farm.

Well on this particular Sunday afternoon we were watching Mustang's across America, Dad says "You know one day before I die I want to do that". I turned to him and said, "Well only one thing stopping us" and his response was "What's that" I said neither one of us owns a mustang dad... jeez

So December 23, 2007 I purchased a 2002 Mustang GT/Roush stage 2. After months of searching for the right car, see it was a 2002 the same year I almost lost my dad, the car was also a Jack Roush Mustang, not a kit car but built back east, the real deal which Dad and I used to always watch Nascar

together so we were fans of Jack Roush.

I had the opportunity to actually meet Jack Roush, at a signing event in Fremont Calif. I had him sign my car in 2 places (the dash was already signed) I had him sign the steering wheel, so I could look down and see it daily, and the passenger side head rest (Jack had to climb in the back seat to sign here) When he stepped out he asked my why there, my response, now I can tell everyone I had Jack Roush in the backseat of my mustang.

**So, just how good of a mechanic are you?**




## An excerpt from the book *Pimp* -

# New World Order

## Update on the Condom Cops

In 2012, the voters of Los Angeles County, California voted "Yes" on one of the most useless, ridiculous and wasteful ballot measures ever written - a law requiring adult performers to wear condoms, making it illegal to film adult videos without the use of a condom. At that time, I wrote a column about the stupidity of Measure B, and the lack of education on the part of uninformed voters which led to the passage of this burdensome, unenforceable law by a 56% margin.

Since that time, I've followed the various legal issues and problems that predictably have arisen in connection with this draconian measure. This is a law that impacts the lives of thousands of people, primarily in Southern California where a large percentage of adult videos are filmed.

Within the adult industry, there has been a range of problems in attempting to cope with this "Big Brother" mandatory condom law - confusion, fear, anger, frustration, lost jobs and other unnecessary disruptions, none of which will make the industry safer and certainly won't protect the general public from STD's or AIDS. I felt it was time to update our Top Floor readers on various legal developments regarding Measure B over the past year.

One of the key players who stepped up to the plate to do battle against this law has been Vivid CEO Steven Hirsch.



Hirsch and Vivid led the way in January 2013 by filing a lawsuit against Los Angeles County stating that it infringes on the First Amendment rights of those who work in the adult industry, making it unconstitutional. Porn stars Kayden Cross and Logan Pierce joined the lawsuit as well.

Paul Cambria, an attorney representing Vivid states,

***They're telling the production house that in order to produce legally protected expression, you have to first get government approval and you have to agree to shoot it in particular way, namely with condoms ... I can tell you they are leaving L.A. County***



***in droves. It's a multi-billion dollar industry that employs thousands of people, and ever since this all started they have been leaving and filming in places other than L.A. County."***

Steven Hirsch said,

***"Overturning this law is something I feel very passionate about. I believe the industry's current testing system works well. Since 2004 over 300,000 explicit scenes have been filmed with zero HIV transmission. The new law makes no sense and it imposes a government licensing regime on making films that are protected by the Constitution."***

Vivid Entertainment asked for a court order to prevent the enforcement of Measure B. I've always admired Hirsch. He's smart, savvy, and he's a big reason why Vivid has remained one of the top players in the industry even in these tough times, so it makes sense that he has spearheaded one of the major lawsuits against Measure B. His remarks are essentially the same arguments that were made at the time it was presented to the voters, but unfortunately the public was easily influenced by various factions and scare tactics which led them to believe that forcing pornstars to wear condoms is a necessary thing for the "protection" of society.

In response to this lawsuit, I'm happy to say that a partial victory came in August 2013 when U.S. District Court Judge Dean Pregerson weakened several portions of the Measure. He wrote a 34-page ruling, stating that it essentially gave the county health department of Los Angeles too much power to deny a filming permit and that the measure is written in language that is far too broad and non-specific about preventing the spread of disease on a film set. He made the logical argument that such vague language could shut down a production simply because a cameraman had a cold.



It's this type of overly broad language that makes Measure B an utter disaster on so many levels.

The judge also found that Measure B violates the Fourth Amendment because it gives the county and law enforcement the right to "enter and inspect any location" where filming is going on. In my previous article, I pointed out that in today's adult industry, which includes not only professionals but amateurs filming in the privacy of their home or via webcam, it's no longer so cut and dried as to what defines a film set. Adult movies are shot in hotel rooms, bedrooms, and various other locales. How on earth could the county of Los Angeles be given the right to inspect "any location" where filming is going on? And where would the resources come from to enforce such widespread intrusions? Would a boyfriend and girlfriend who film a sexy cam show from home to earn a few extra bucks be subjected to cops or "health inspectors" busting into their home to make sure the boyfriend has it "wrapped up"? The judge says "NO", and thereby further weakened Measure B with his ruling.

Another key element of the judge's ruling is that law enforcement would be required to obtain a search warrant to go in and inspect the premises for condom use.

Porn industry attorney Michael Fattorosi says,

***"Measure B will now be much harder to enforce than it already is. But condoms remain a required aspect of shooting porn in Los Angeles County and California. The real question is does the County want to enforce a condom law that will now require a warrant for a search in order just to find violations. In my opinion, I doubt the County will have the man power, the resources or the funding to start searching sets especially since they will not be able to charge fees for their permits."***

I certainly agree with Fattorosi on this - without a source of funds to enforce this mess of a law, it seems doubtful that the County would want to get search warrants for every suspected violation.

Again, a victory against the Condom Cops.

So it is becoming more and more clear within the court system that what we have here is a stupid law that is basically a) unconstitutional b) unenforceable and c) unfundable

Unfortunately, the key elements of the law - requiring adult productions to get a no-cost permit to film from the county and that adult performers must wear condoms or face criminal charges, still stands as of this writing, since the judge did not strike down those elements. Steven Hirsch and Vivid were pleased that certain portions of the law were deemed to be unenforceable and unconstitutional, but disappointed that the key element of the law requiring mandatory condoms still stands.

Michael Weinstein, President of AHF (Aids Health Care Foundation) and backer of Measure B called the judge's ruling a "victory" and that it would "go a long way to safeguard the health and safety of adult performers working in the industry".

Steven Hirsch fired back with vows to continue the fight,

***"We continue to believe this unfunded mandate infringes upon our freedom of speech and we will continue our fight by filing an immediate appeal to this portion of the court's ruling,"***

In yet another interesting legal development, upon the appeal filed by Steven Hirsch/Vivid, a private attorney hired by the County of Los Angeles declined to file any sort of court brief in defense of the condom law, which certainly looks as if the County realizes that this is a stupid and bad law not worthy of defense.

At the heart of the ruling is the concept of free speech and free expression. The judge, by continuing to uphold the mandatory condom portion of the law, has stated that the adult industry doesn't have a valid first amendment/free speech argument, whereas the industry says that forcing a filmmaker to require performers to wear condoms absolutely infringes on their artistic freedom to depict condom

free sex. I agree 100% with the industry position,. The only thing I would do differently is to somehow change the culture within the adult world so that any performer who requests that condoms be used on their shoots not be banned or blocked from the industry by producers, thus insuring that everyone's free choice really is respected. In my mind, that's what freedom is - not just one person or one group's version of it.

I've attempted to see both sides of the problem, because there are performers, both male and female, who do want to use condoms, and I feel their wishes should also be respected. It is their health, their body, and their choice.

On the human side of the equation in observing how things have gone since the passage of Measure B, it's clear that many performers don't know what might happen to them or what the future ultimately holds for the adult film profession until this matter is thoroughly settled in the courts. Even if the law stands, I can't imagine how it could really be enforced. But that doesn't make life any easier for now. I know that a number of performers are having to travel a lot more to areas outside of Los Angeles County to film, which obviously puts a strain on their ability to make a living, slows down production at all levels, and generally creates distress and havoc.

I realize that it's easy for people outside of the adult business to snicker and laugh about this matter. The idea of "condom inspectors" on porn sets brings out the comedians who think it's all too funny. But jokes aside, it truly is a free speech issue, particularly with the continued growth of amateur porn and webcams.

These are legal age adults who have chosen to work in this profession and they know the risks. They are tested twice a month.

They enjoy what they do and if they don't, they can quit and do something else.

As far as I know, the law hasn't actually been enforced (I haven't heard of any performers or producers being fined or thrown in jail for not using condoms), but that doesn't mean enforcement efforts aren't underway at some level or that we won't see certain performers made into scapegoats just to prove a point and instill fear into the profession as a whole.

As I stated in my previous article, the Aids Health Foundation which sponsored this Measure would be better off putting their money and educational resources into reaching out to the general public about the risks of unprotected sex rather than using the NON-issue of mandatory condoms for pornstars so that they can enrich themselves and conduct a bunch of fundraising to line their own pockets.

So, welcome to 2014!

It will be a bumpy ride, but it certainly won't be dull!

I'll continue to keep our readers updated and hopefully this year will be the end of the Condom Cops!


