DARRELL ISSA



I Google searched Darrell Issa and without paying any attention, I clicked on the first search result.

From the beginning, on the home page, I found a very disturbing press release...

March 13, 2014

Washington, D.C. – By a vote of 233-181, the House of Representatives today approved the Executive Needs to Faithfully Observe and Respect Congressional Enactments of the Law (ENFORCE the Law) Act (H.R. 4138), a carefully crafted bill to rein in the growing problem of executive overreach and restore balance to the separation of powers enshrined in our Constitution.

The ENFORCE the Law Act, introduced by Repre-

Oval Office by allowing Congress to authorize lawsuits against the Executive Branch when they fail to uphold our nation's laws. The Constitution charges the President with the responsibility to faithfully execute all the laws and not just the ones he supports. The Executive Branch has grown so bloated and convoluted that it now comfortably abuses its power knowing that the complexity of its actions and judicial procedure will effectively allow it to circumvent the other two branches of our government. We must restore a working system of checks and balances that ensures the government's actions are judged on constitutional merits rather than bypassed or delayed based on the political whims of the President and his appointees. This legislation provides the

sentatives Trey Gowdy (R-S.C.), Darrell Issa (R-Calif.), House Judiciary Committee Chairman Bob Goodlatte (R-Va.), and Representative Jim Gerlach (R-Pa.), puts a procedure in place to permit the House, or the Senate, to authorize a lawsuit against the Executive Branch for failure to faithfully execute the laws.

Yes, you read it right. Congress passed a bill that would allow them to file a lawsuit against the **PRESIDENT OF THE UNITED STATES.**

The reason?

According to Darrell Issa - "President Obama has established a disturbing pattern of cherry picking the laws he wishes to enforce. The House acted decisively today, to bring accountability back to the simple expedited procedure that lawmakers and the American people need to hold their federal government accountable."

How has President Obama abused the power given to our executive branch?

The Heritage Foundation - a republican think tank - list Obama's appointment of Richard Cordray to serve as the director of the Consumer Financial Protection Bureau as one example. They claim that since this appointment was done during a time when Congress was still in session because the House never consented, this broke with over 100 years of precedent.

The Justice department has a totally different take on what happened. In a 23 page legal opinion, the Justice department summarizes the legal advice given to the White House **BEFORE** President Obama took action.

Assistant Attorney General Virginia Seitz wrote that the president has authority to make such appointments because the Senate is on a 20-day recess, even though it has held periodic pro forma sessions in which no business is conducted. Seitz argued the pro forma sessions – some with as few as one member present – have not been sufficient for the chamber to exercise its constitutional authority to advise and consent to normal presidential nominations.

Her new memo cites a Justice Department legal opinion from President George W. Bush's Republican administration in justifying Obama's recent appointments. The Bush administration opinion from 2004 says that a recess during a session of the Senate can meet constitutional requirements for permitting the president to make recess appointments as long as the recess is of sufficient length. Seitz noted that the last five presidents have made recess appointments during recesses of 14 days or less.

I'm sure that the 228 republicans and 5 democrats that voted for this bill had to have known that no precedent had been broken and that the entire process was a legislative waste of time. invoking her 5th amendment rights, Chairman Issa shut the hearing down, excused the witness and turned off ranking members Elijah Cumming's microphone in the middle of his statement...<u>then Issa</u> <u>walked out</u>.



His actions led to the House Democrats submitting a formal resolution for a vote of condemnation. The resolution was defeated after Issa issued an apology to Cummings but then went on Fox News with his chest puffed out showing absolutely no remorse for his actions.

Darrell Issa should not be condemned because of what he did to Cummings. It's his criminal background that should get him removed altogether.

 Issa has been arrested for grand theft auto after stealing a Maserati from a showroom. That case

Any Committee on Oversight and Government Chairman that was worth a damn would have shied away from that BS - but then there's Darrell Issa.

Issa has investigated everything from the health care act to the IRS. If it's something that might give the Obama administration a black eye then Darrell Issa is trying to get to the bottom of it.

Some would say that he's just doing his job and so it would seem. It wasn't until yet <u>ANOTHER</u> IRS hearing where Issa abruptly stopped ranking member Elijah Cummings from doing **his job** that it became crystal clear that Issa is more interested in conducting a dog and pony show than investigating.

After IRS official Lois Lerner refused to answer the committee's questions for the second time by

was dismissed.

- Issa paid a fine and was sentenced to six months probation for possession of an unregistered gun after an Ohio police officer pulled him over and found a .25 caliber pistol, 44 rounds of ammo and a tear gas gun.
- The least investigated incident occurred after one of Issa's car alarm factories blew up. This was after Issa removed all of the important files and quadrupled his insurance on the property.

This is the guy that was appointed to investigate the government - What a joke!

And we are the one's paying for this comedy with our tax dollars...so the joke is on the American people! Where, for God's sake, is the outrage?






Let's see, we have phones that not only make phone calls but search the web, play all of your favorite videos, music, television programs, games and take pictures.

We have televisions that we can talk to, video game consoles that double as a top of the line Blu-Ray disc players and computers.

There's a watch that takes calls and glasses that will record your life as you wonder through this wonderful world of ours. The pistol has a green light that indicates the status of the gun...no green light and the firearm is useless.

As you can see to the right, the watch has to be synchronized with the gun, a pin code has to be entered and the user must select a time frame for use.

That's confusing.

Unless the firearm is being used by an on-duty police officer, how would you be able to determine a

All that's missing is a smart gun!

Wait...nope, got it!

Germany company **Armatix** seems to be the first in line when it comes to "smart" guns, introducing a firearm that is linked to a watch by an RFID (radio frequency identification) chip.

In order to be discharged the gun must be near the watch.

Get this...the watch is waterproof and ALSO KEEPS TIME!

Ahh...I remember the days when just having a waterproof watch was all the craze. time frame for its use?

Here's the part that really had me puzzled...gun control advocates are really behind this weapon. They feel that it's a step toward reducing gun violence,



Taking Aim at the U.S. Market

Companies are developing guns that work only with authorized users. A look at two:

RADIO-FREQUENCY TECHNOLOGY

Armatix: iP1 pistol and iW1 RFID watch

After synchronizing the gun and watch, the gun is activated by entering a five-digit personalized PIN code into the watch and selecting a time frame for its use.

A radio-frequency signal -RFID- from the watch enables the gun to be fired only by someone wearing the watch.

BIOMETRIC TECHNOLOGY

Kodiak Industries: Intelligun

Gun is unlocked after the user's fingerprint is read and recognized and relocks when the gun is let go.

This system may be disabled with a special key.

The whole idea of a smart gun has become a hot ticket item among manufacturers and investors.

Ron Conway, early investor in Google and Facebook, has offered a \$1 million prize to for new smart gun technology.

TriggerSmart has also manufactured a RIFD firearm that uses a ring instead of a watch.

Kodiak Arms, a Utah company, is already taking orders for it's *Intelligun* that utilizes fingerprints to unlock the weapon.

The Violence Policy Center has taken an entirely different position stating that the new technology

suicides and accidental shootings. Some have even went as far as to liken the RFID chip to the air bag on automobiles.

Then there is the other side...

Gun rights advocates are wondering what will happen if the technology fails or if an intruder breaks in during a time when the firearm isn't "scheduled" for use...my thoughts exactly. will have little if no impact on gun violence.

I have to say that I agree with them.

- Every day in the U.S., an average of 289 people are shot. Eighty-six of them die: 30 are murdered, 53 kill themselves, two die accidentally, and one is shot in a police intervention.
- One person is killed by a firearm every 17

Lawmakers in New Jersey and California have already jumped on board, passing legislation that would require that only smart guns be sold in the state within three years of it's availability.

That's where they lost the NRA!

The NRA looks at the smart gun as just another opportunity for the nasty 'ol government to stick their dirty hands into the gun industry.

Though the NRA refused an official comment on the smart guns the group opposes "government mandates that require the use of expensive, unreliable features, such as grips that would read your fingerprints before the gun will fire." This is according to their lobbyist. - *Washington Post* minutes, 87 people are killed during an average day, and 609 are killed every week. (source: CDC)

- Handguns comprised 72.5 percent of the firearms used in murder and non-negligent manslaughter incidents in 2011; 4.1 percent were with shotguns; 3.8 percent were with rifles; 18.5 percent were with unspecified firearms.
- Nearly three times more kids (15,576) were injured by firearms in 2010 than the number of U.S. soldiers (5,247) wounded in action that year in the war in Afghanistan (source: CDF, CDC, Department of Defense)
- Half of all juveniles murdered in 2010 were killed with a firearm (source: Office of Juvenile Justice & Delinquency Prevention)

PROS

There are several pros that I can think of ...

- The Smart Gun could potentially decrease the number of children that accidently shoot themselves or others.
- It could potentially prevent being shot or killed by an unarmed intruder (if there is such a thing) that discovers a gun in the home.
- It could also potentially decrease the number of individuals shot or killed at the hands of a loved one with their own gun.
- The Smart Gun could impact the number of suicides.

CONS

- The timer on the gun could put the user in danger in the event there is an intruder or they are in a situation where they need to react quickly.
- Having a firearm that relies on anything but a finger to pull the trigger could be dangerous what if you can't find the watch. A ring makes a little more sense because it's unlikely that you will remove it to go to bed. How many people sleep with a watch on?

Let's start with the price!

The cost of Amatrix's .22 caliber pistol is \$1,399 and that doesn't include the watch! The watch is \$399. The cost of the average .40 caliber Glock handgun is \$600.

In fact, why are we even talking about this?

The Smart Gun is a toy for gun collectors.

The Smart Gun is the equivalent of Google glasses, PlayStation 4 and the smart television.

The fact that there are legislative bodies like those in New Jersey and California that are passing laws to only sell smart guns is nothing more than a blessing for the manufacturers that create them.

Are they planning to remove or ban all the other firearms that were previously purchased in their state?

What are they going to do about semi-auto and automatic weapons? Are they planning to discontinue those sales without backlash from the NRA and gun loving citizens?

I think not!

Honestly, I believe that if there were **NO OTHER OPTIONS** then the Smart Gun might be a good

- What happens if you forget your PIN number?
- But the biggest con of all...

product

itself!

idea.

The price alone could be a deterrent to your average criminal.

The problem here is that **NOTHING** is being done to eliminate the **other options**.

And yet for whatever reason, here we are - being convinced that a "smarter" gun will somehow impact **ANYTHING**!

We really can't afford to be that confused or easily misled, especially when it comes to firearms in the most violent country in the world.

Guns don't kill people, it's the people with guns that kill people. It's the people using guns that need to be smarter not the gun!

Anti Porn Crusader Shelley Lubben - Did the Devil Make their deepest beliefs. It's their personal right to leave the adult business if they want to. No one is forcing them to stay. But when ex-performers arrogantly decide that they have the right to shut down or censor the adult business by launching religious or political crusades, then it becomes a different matter. Shelley Lubben is one of those ex-performers who has made it her (highly lucrative) business to smear the adult industry. In 2007, .Lubben and her husband founded an organization called The Pink Cross Foundation, a Christian outreach "ministry" which ostensibly rescues victimized adult performers from the evils of the porn business. Ms. Lubben has aggressively propelled herself into the public policymaking arena as an extremely high profile media spokesperson, referring to herself as "Dr. Lubben" (with a supposed degree in theology from a non-accredited diploma mill.) She sure ain't a doctor - of theology or anything else.

Over the past few years, she's been a sought-after national and international speaker, counselor and political lobbyist against the adult industry. She's provided testimony in front of city councils and various influential health and safety task forces about the porn industry, and unfortunately for the American public, her self-serving, self-promotional agenda has swayed high-ranking officials who are more than happy to use her as their anti-porn "poster girl".

Her Do it?

The adult film biz is endlessly fascinating, not just for the obvious reasons - those outrageously hot babes and guys! But because there's so many raging controversies in its ranks - free speech issues, health issues, political and personal rivalries and the list goes on. One of the most controversial scenarios arises when certain adult performers leave or retire from the business and suddenly decide that it's their personal mission in life to stamp out the "evil" porn industry. They find God or follow a different path.

Hey, I'm all for personal choice and people following their dreams, whatever those may be. For me, it's always been a central tenet to fight for people's rights - to live as they want and stay true to their



When I first heard of Shelley Lubben, I knew very little about her. Who was she? What were her motives? I occasionally saw a few clips of her on Hollywood Blvd. handing out Pink Cross brochures to street kids, and at first, I thought maybe she was doing some good in the community, or at least no harm. It took some digging to sort it all out and filter fact from fiction. Her story in a nutshell: she claims that during her time as a pornstar under the stage name "Roxy" (1993-1994, yes, all of ONE year) she suffered severe health damage, catching genital herpes and HPV (human papilloma virus), and cervical cancer requiring the removal of half of her cervix. But if you look closely at her real story, these claims become highly questionable. As they say, there's always two sides to every story, and in the case of Shelley Lubben, there seems to be 10 or 15 or 20 sides which constantly change and evolve depending on her mood.



became pregnant three times by "tricks", having a child by one of them. But according to her, a brief stint in the porn industry is to blame for all her mental and physical disasters.

When she's asked how that brief time in porn was responsible for her reproductive health problems, her response is that she used condoms as a prostitute, but not as a porn performer, since condoms were not required on adult film sets. Apparently, she expects people to believe that during six years working the gritty streets of Los Angeles as a hooker, condoms were always used. Seriously? She, herself, openly reveals several instances where guys refused to wear condoms. And obviously, getting pregnant by a client is proof that she didn't always use condoms. How stupid and gullible does she think people are to believe her ridiculous assertion that she "always" used condoms as a prostitute?

She can't keep her multitudes of stories straight.

In her rabid attacks against the adult industry today, she always conveniently omits the fact that performers working in the U.S. are legally required to be tested monthly for a range of STD's including herpes, AIDS, and syphilis, unlike prostitutes who are under no such requirement except in legal brothels in Nevada. With such a testing regimen in place, anyone with a modicum of logic can see that performers in the adult industry today are SAFER and healthier in terms of their STD status than the average American out there in the dating world, picking up random partners for one night stands, and they're absolutely healthier than untested street prostitutes such as she was. . It's true that in 1993 when she was on sets, the stringent testing procedures were not in use. But testing is mandatory today, and she has the ethical obligation to acknowledge this fact when she dishonestly paints the adult business as a rampant, disease-spreading threat to humanity and public health. But ethics aren't her strong point, so the lies and half-truths continue to spew. .

By her own open admission, she spent over eight years as a prostitute working the streets of Los Angeles from ages 18 to 26. She entered the adult film industry at age 24, which means she was working as a prostitute at the same time. She was in the porn business for about 1-2 years and made approximately 17 films during that time, depending on which database you reference. So, she spent six years sexually "servicing" hundreds of men for pay BEFORE she ever set foot on an adult film set at age 24. She was also a drug addict and alcoholic and became

I must say, I was utterly fascinated and riveted by the extremely meticulous fact-finding of Whiteacre and Lee regarding Shelley Lubben's personal history, her mental health problems, her twisting of the truth, and the way she and her husband have profited at the expense of people who make their living as adult performers. It's a profound eyeopener, and regardless of which side of the spectrum you're on regarding porn, it's obvious that a tremendous amount of work went in to the production. It contains facts which Ms. Lubben, as far as I can determine, has not disputed. She's made no effort to openly debate Mr. Whiteacre or Ms. Lee.

If the material in "The Devil And Shelley Lubben" were false, she would have sued them, but as the saying goes, "you can't sue if it's true." It's done in a clear, concise manner that leaves no stone unturned and I applaud them for their efforts. This documentary should win an award and I hope it does!

Instead of being a grown up and pointing the finger where it clearly belongs - at herself - for a lifetime of poor judgments and mind-blowingly crappy choices, Shelley Lubben shifts the blame to an entire industry as her scapegoat. And it's ludicrously easy to use her own words against her. . Shelley Lubben speaks to audiences and groups who are totally naive about the business, and without doubt, this suits her just fine. She promotes the stereotype that people who go into adult are drug addicts, runaways and desperate mental cases. These inflammatory portrayals and blanket accusations against "all" people in adult is just another of her techniques to smear.

Are there people in porn with mental issues? Yes.

Are there lawyers and doctors and secretaries and preachers and teachers with mental issues? Yes.

And let's not forget the tons of "mainstream" actors in Hollywood who do insane stuff, yet no one advocates banning the acting profession because a percentage of actors do crazy or illegal things "off set".

that she can't avoid, no matter how many ways she spins it, is that she willingly, consensually, as an adult, sought out employment in the adult world, performed sex on camera willingly, and was not forced to seek this employment. She cashed the check, baby. She signed the waiver and did the deed. A male performer who shot scenes with her at the time remembered her as a consensual, sober, and aggressive participant. He was shocked to hear her claim, 16 or 17 years later, that she'd been raped or abused on set in any way. During those years, he invited her to his home for an industry party which she attended and continued to actively "network", looking for more work. Certainly not the actions of someone who felt terrorized or fearful. As always, Ms. Lubben indulges in outrageous revisionist history about her time in the adult world for her personal

There's no industry or profession under the sun that doesn't contain some people with mental issues, yet no one says that those industries should be banned, censored or wiped off the face of the earth. I would venture to guess that there's LESS mental illness among sex workers due to the fact that most of them truly enjoy what they do, they are comfortable with their own sexuality, and they know they're under constant scrutiny.

They're fully aware that society views them in a negative light, and yet they stand up for doing what they personally enjoy - portraying sexual fantasies on camera for their own enjoyment and that of their audience.

Let me make clear: I respect Ms. Lubben's right to express her religious and philosophical views about the porn industry. If she feels it's morally wrong in the sight of God to portray sex acts on screen for money, she has every right to speak her mind and say so. What she doesn't have a right to do is actively mislead people, to lie, to provide half the story, to spin her own back story, or harm the livelihoods and career CHOICES of other people by denouncing them and destroying their ability to earn a paycheck. She shows up at porn conventions to "warn" fans of the dangers of porn. If she hates it so much, why doesn't she stay away from it? She can't stay away because her Pink Cross is a business, it's the way she pays her bills and the mortgage on her house, as a speaker, "activist", "consultant", and "evangelist". She doesn't do it for free. Money motivates Shelley Lubben. I highly doubt she'd be out there with her expensively highlighted blonde hair (and believe me, I know how much THAT shit costs!), doing her crusader routine, if it weren't lucrative for her.

After watching Michael Whiteacre and Lydia Lee's documentary and doing my own research into the mater, the most important message I take away is this: we all need to own our decisions in life. . If you turned right when should have turned left or you chose the wrong job or hang out with destructive, criminal friends, or you went into porn. Guess what? You have to own it. Owning it is the one thing Shelley Lubben is incapable of doing. . The devil didn't make her do it. She chose to go into prostitution at 18. She chose to go into the adult business at 24.
